The notes from the last meeting were agreed.

Actions from last meeting:

Tony has submitted the risk assessment

Oiling of benches - still outstanding and carried forward.

The bulb planting has taken place

Andy has printed stick on labels showing return address to be attached to the membership form. (These were distributed in the meeting)

Tony has received conformation that the risk assessment and constitution had been accepted.

Facebook/website

We were unclear whether a membership form could be added to facebook. However Andy will meet with Gary who is helping develop the website and this will have the membership form for people to download. Andrew suggested adding a motto or strap-line.

Our facebook page is now linked on the BANES website. Due to financial regulations it has been decided not to have a donation facility but the bank details will be added.

Tony has been speaking to Laura the current facebook admin. She is looking to hand this over to the group and is willing to give a teach-in. Mary and her husband, Joyce, Andy and Tony all expressed an interest in meeting with Laura to learn more about what was entailed. A meeting with Laura will be arranged.

Fencing

Andy, Tony and Lorinda have visited some of the local parks to see what types of fencing were in use. Andy showed photo's that he had taken. Everyone was in strong agreement that we would remain a separate entity from the Weston Group but would benefit from receiving updates of their progress.

Membership

Andy and Tony will liaise with Mary, Joyce and Laura to arrange a training session.

Andy will raise the fencing timescale with Paul Pearce.
